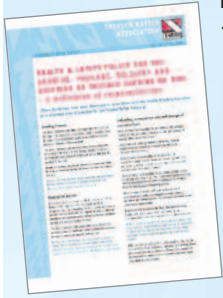


- Use of the TRA logo – providing market recognition and giving clients confidence.

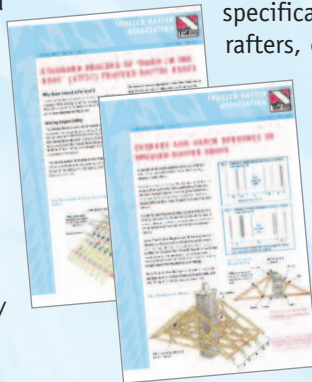
- Advanced warning on health and safety campaigns and methods to satisfy HSE requirements.

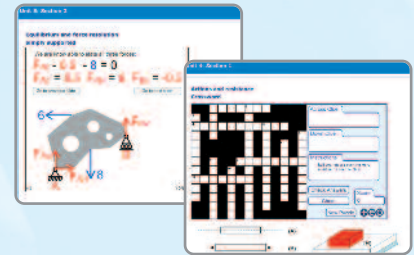
